- 2. The MAXIMUM amount of Money Damages You May Petition the Court for is \$6,000.00. The current filing fee for a Small Claim with one defendant listed is \$75.00. Each Additional defendant listed requires an additional \$10.00. Service of Summons to the party or parties you are filing against will be issued by certified U.S. Mail. IF YOU DESIRE BAILIFF SERVICE, that fee will be \$25.00 PER PERSON listed.
- 3. You can only file a Small Claim for yourself. Only an attorney may represent and file a claim from someone else.
- 4. You must Supply the Court with the <u>Correct</u> Name and <u>Correct</u> Mailing Address of the Party or Parties You Are Filing Against. <u>IT IS YOUR RESPONSIBILITY TO MAKE SURE ALL FORMS</u>

 <u>ARE FILLED IN PROPERLY and COMPLETELY!</u> The Clerks are not permitted to help you fill out the forms. Please, Do Not Ask.
- 5. Filing a Small Claim Complaint **DOES NOT GUARANTEE PAYMENT** of your Claim.
- 6. Although the Court Will Issue a Summons to the Party or Parties You File Against, this Does Not Insure Their Appearance in Court on the Scheduled Hearing Date. A Warrant for Non-appearance <u>Cannot</u> be Issued for this Type of Case.
- 7. If the Defendant Fails to Appear, You May Be Granted a Default Judgment. If You Are Awarded a Default Judgment, this Means You Have Won the Case.
